THE YEAR IN REVIEW - ALL

- In 2022, the court was not able to report fully against the international court performance indicators due to the cyber-attack. Despite the aftermath, the court has pulled together all available resources and worked extra hours in re-entering majority of the lost data in the '2022 Data Recovery Project' run in 2023 and am very pleased to announce that as a result am able to report again on the court performance indicators end of 2023.
- 2023 was a very busy year for the Vanuatu Courts in respect to total cases filed. Over 3,400 cases filed across the four jurisdictions, this is the workload on the courts and upon court administrators.
- The Supreme Court in particular saw over 800 cases filed, almost 20% increase on previous years, while the Magistrate Court again saw decrease of more than 5% of cases filed. It is also most pleasing to see the Island Court's filings steadily reflecting its improved accessibility across the country, with over 390 cases filed compared to 329 cases in 2022.
- With respect to the international court performance indicators that we work to, we have seen a satisfactory result with Clearance Rates – three out of the 4 jurisdictions are under 100% due to increase in filing (which means our pending #s increased). In addition, the significant increase in workload, time to finalise cases across criminal and civil matters, two out of four jurisdictions has reduced, a remarkable achievement.

CONTINUED

- Pending numbers has always been one of the main key indicators of the courts, our overall numbers have increased.
- 2,949 cases are now pending across the four jurisdictions, with 46% in the Magistrate Court. Of concern is the high Pending to Disposal Ratio (PDR) in the Supreme Court & Island Courts. The lower the PDR the better, and ideally 1.0 for the Supreme Court and 0.5 for the Magistrate Court.
- Court of Appeal doing exceptionally well with PDR of 0.2
- Additional judicial resources may be needed to deal with the growing number of filings and the increased # of pending cases.
- Another key indicator is the Attendance Rate (measures the number of visits/appearances at court to dispose a matter). The target for all courts internationally is to keep this indicator as low as possible. The attendance rates for completed cases in the year 2023 has been consistent to 2022.
- The productivity of our judges and magistrates still remains consistent, despite having less judges & magistrates, again this reflect a solid year, with respect to disposals per judicial officer on average with 116 per Judge and 267 per Magistrate in a year.

CONTINUED

- The Court of Appeal yet again continues to provide world standards such as timeliness being consistent & clearance rate. Despite more cases being filed, CoA still managed to finalize cases bringing its clearance rate to 119%, of highest quality in service to this country.
- There continues to be a similar percentage of Supreme Court cases being appealed - running at 8%.
- The ongoing commitment that the Supreme Court shows to the criminal workload has ensured the timeliness of cases to be finalized (average is less than 180 days), The attendance rates (approximately 4 attendances), and the relatively low number of pending cases reflects a positive outcome for this work in 2023.
- With Civil cases, attendance rate still high due to completion of many old cases which has direct impact and cost to the parties. Most of our current pending cases are under judicial management and we are working to ensure each case has a future listing date, (another international court indicator).
- The enforcement matters in the Supreme Court has seen attendance rate similar to civil matters and is still high. Preferable to see the rate lower and will be looked at in the first part of the year.
- Reserved Judgments in the Supreme Court now stand at 44 cases and approximately half of these judgments are older than 90 days and will continue to be a focus for Judges in 2024.

CONTINUED

- From an Island Court perspective, the clearance rate at 98%, is a positive improvement, still more resources needs to be allocated to the Island Court to tackle the continuous increase in registration however, a positive turnaround in registration and finalization of cases in 2023 - reflecting confidence building up in the Island Courts.
- Finally, with respect to the Magistrates Court, as mentioned earlier the Court took on a record where the number of filings are slightly down on previous years and finalization has significantly decreased compared to 2022. A possibility of this decrease is because some of the outer islands still doing manual registration e.g. Malampa, Tafea and others – needs actioning in 2024.
- Over the last years, filing of PI in the Magistrate court has increased substantially.
- Criminal matters in the Magistrate court have decreased in 2023.
- Filing of DV cases are low compared to 2022 but still consistent above 1000 but finalization did not match the incoming workload in 2023.

CONTINUED

- Finally, as we reflect on the performance of cases dealt with across the four jurisdictions, we will continue to drill into more specifics such as who appears before us – for example, gender, as well as the criminal charge outcomes and charge orders associated with the cases. The 2023 detailed analysis will appear on the website within the week.
- We have at our disposal more court performance indicators which allow us to assess the operation, impact and efficiency of our case management protocols and ensure greater transparency about the performance of the courts, and insights into case management.
- Our ability to reflect on the performance of the courts at the end of 2023 is a credit to the Chief Registrar and his team, and as I have mentioned in previous years, our ability to present to you, the Government and the Community, our 2023 performance analysis within the month of January is testament to the work of many.

SUPREME COURT

Key Messages

- SC filings again were over 800 – with 840 cases filed
- SC finalization were up from 2022 at 757
- Clearance rate less than 100% - at 90%, but overall, the last 8 years at 103% - a solid effort
- Pending increase over 800 at 923, due to high filling in 2023
- PDR is 1.2 – which is slightly above the target of 1.0 for any Supreme Court
- There are still approximately 24% of cases older than 2021 that should be assessed
- Timeliness for completing Criminal cases continues to be consistent – now at 193 days versus 198 last year – and Civil cases also consistent from 484 days to 493 days – a good result

Overall

- Pending still manageable amongst the judges and 24% of cases are older than 3 years – needs actioning
- Judicial output (productivity) – as calculated by disposals/full time Judicial Officer – remains consistent compared to previous years, despite less Judge in 2023 – good performance by the Judges
- Overall number of cases without a future listing has increase from previous years:
 - Only 45% of all pending cases have a future date (benchmark is 80%)
 - Over 55% are under ‘case management’ without a future listing.
- Attendance rates (which impact and cost to the community) are being monitored carefully. Some variance between case types – but overall similar to 2022

MAGISTRATES COURT

Key Messages

- MC fillings were slightly down in 2023 from 2294 to 2160 - a decrease of 6 %
- MC finalizations were significantly down compared to 2022 from 2270 to 1833 – a decrease of 19 %.
- Clearance Rate was under 100%, at 85% in 2023 – the overall average for the last 8 years is at 100%
- Pending increased significantly from 918 in 2022 to 1357, thus adding over 400 cases to Pending #s
- PDR significantly increase to 0.7
- There are still approximately 28% of cases older than 2 years that should be assessed.
- Timeliness for completing Criminal cases – reduced from 172 days in 2022 to 145 days in 2023

Overall

- Pending case numbers (open cases) increased significantly due to the Clearance Rate less than 100% at 85%.
- MC has a Pending to Disposal Ratio (PDR) of 0.7 which equates less than a year worth of outstanding cases. (Target is 0.5)
- Judicial output has remain consistent at 262 cases per Magistrate per year, despite one less Magistrate in 2023 – a good performance
- Overall number of cases without a future listing has increase from previous years:
 - Only 25% of all pending cases have a future date (benchmark is 80%)
 - Approximately 50% are under 'case management' and
 - 25% of without a future date
- 13 cases under Reserved Judgment

ISLAND COURT

Key Messages

- IC filings – increased over 20% in 2023, from 329 to 395 cases filed, compared to 2022
- IC disposals significantly increase from 238 cases to 388 a great increase of over 60% of 2022.
- Clearance rate just under 100% - at 98% - an increase, from 72% in 2022
- Pending slightly decrease from 701 to 652 cases – a decrease of 7% - still too high
- PDR at 1.1 - still too high
- There are now approximately 61% of cases older than 2 years equating to 398 cases that should be assessed

Overall

- The continued increase in filing is a positive sign for the usage/patronage of the Court.
- A good finalization of cases this year has resulted in the Pending workload decreasing, gradually building back the confidence for the community to the Island Court
- Overall # of cases with a future listing is 33%
 - 57 % of cases are under case management and
 - 10% with no future date



I. CASE WORKLOAD

SUPREME COURT TOTAL WORKLOAD



Cases being filed in 2023 again over 800 cases reflecting a very high workload. Clearance rate 90% less than the targeted 100% - but finalization were up on 2022.

The overall average for the last 8 years is 103% - solid performance over a long period.

SUPREME COURT CRIMINAL WORKLOAD




With Criminal cases being filed by the OPP #'s it has been consistently over 200 cases in past 4 years, compared to 2022, 246 is well over 206 – almost 20 % increase. Clearance rate for the year is around the same as in 2022, 93 %, below the target of 100%.

The overall average for the last 8 years is 99% - still solid.

SUPREME COURT CIVIL WORKLOAD




Civil cases being filed has increased from 260 in 2022 to 292 in 2023, however Clearance Rate is well below target rate 100% to 74% in 2023 as finalizations have dropped – thus Civil Pending #s grew by almost 80 cases.

The overall average for the last 8 years is 107%.


SUPREME COURT ALL CASE WORKLOAD


SUPREME COURT WORKLOAD TRENDS




Cases filed were significantly down in 2023 and finalizations were significantly down compared to previous years, and this means unable to reach a Clearance Rate of 100%, at 85% in 2023 – adding over 400 cases to Pending #s.

The overall average for the last 8 years is 100%

MAGISTRATES COURT CIVIL WORKLOAD




Civil filings & finalizations were slightly down from 2022, lowest seen over the past years.

The overall average for the last 8 years is 121% - a solid performance, meaning civil pending #s have dropped.

Protection orders (non-criminal) filings are slightly low but still consistent above 1000 in the last 3 years but finalizations did not match the incoming work in 2023 – which warrants investigation.

The overall average for the last 8 years is 97%.

PI matters filed by the OPP were the highest for many years. Finalizations remained similar to 2022 and Clearance was a low 73% in 2023, with almost 100 cases added to Pending #s. Average clearance rate over the last 8 years is 94%.

This workload is thus expected to flow on to the Supreme Court in the coming year.


MAGISTRATES COURT CRIMINAL WORKLOAD



The filings emanating from VPF/SPD has decreased significantly compared to previous years, the lowest seen for criminal matters. Like filings, the lowest finalizations #s seen. Clearance Rate dropped to 81%, with Pending #s increasing by over 100 .The overall average for the last 8 years is 101% - still solid.


MAGISTRATES COURT ALL CASE WORKLOAD

MAGISTRATES COURT LOCATION WORKLOAD




ISLAND COURT CRIMINAL WORKLOAD


ISLAND COURT CASE WORKLOAD

ISLAND COURT LOCATION WORKLOAD





PENDING CASES BY COURT




PENDING BY COURT BY CASE TYPE


PENDING SUPREME COURT BY CASE TYPE


PENDING MAGISTRATES COURT BY CASE TYPE


PENDING ISLAND COURT BY CASE TYPE

PENDING BY COURT BY LISTED OR NOT LISTED





Cases with a future listing (shaded blue) should typically be approximately 80% of the pending case load. Each court has a significant challenge to address the high % of cases without future listings, e.g., especially the Magistrates Court. The impact on the parties cannot be under-estimated by this low % of listed matters i.e. not aware of what may be happening next.




PENDING AGE SUPREME COURT

PENDING AGE MAGISTRATES & ISLAND COURTS



PENDING TRENDS AND PDR




The lower the PDR (Pending to Disposal Ratio) – the better. Supreme Court has a high PDR approximately 1.22 which equates to more than a year worth of outstanding cases. (Target is typically 1 or less for a superior court)

Magistrate Court has a PDR of 0.74 which equates to more than half a year’s work. (target is typically .5 or less for a lower court)




About 45% of the overall pending caseload is listed/ready for trial/hearing (benchmark is 80%).



Clearance Rate are under 100% for all courts except for Court of Appeal at 119.0%, in 2023.



DISPOSAL RATES PER JUDGE & MAGISTRATE




TIMELINESS DISPOSED CIVIL CASES

TIMELINESS DISPOSED CRIMINAL CASES




Criminal cases average days to dispose is the same compared to last year and very solid and reflects the commitment to dealing with criminal matters in a timely manner for the country.

COURT OF APPEAL WORKLOAD TRENDS




CoA filing has been very similar to the previous 3 years . Finalized cases has increase by 56% in 2023 compared to 2022 , however on average remains the same over the past years.


COURT OF APPEAL CIVIL




Criminal CoA workload in 2023 returns to levels seen prior to 2022.


SUPREME COURT CRIMINAL CASE OUTCOMES

MAGISTRATES COURT PI CASE OUTCOMES




In PI matters, approximately 8% dismissed and 12% withdrawn, and the remaining 80% committed. This is a reflection of the quality of the cases presented by the OPP.

MAGISTRATES COURT CRIMINAL CASE OUTCOMES




CHARGE OUTCOMES



Attendance rates, as measured by the number of visits/appearances at court to dispose a matter is now being tracked.


SUPREME COURT COMPLETED ATTENDANCE RATES


SUPREME COURT PENDING CASES ATTENDANCE RATES




Largely consistent over the years for the main case types, Criminal, PI and Violence (protection orders) – the attendance rates are generally in-line with good practice for Magistrate Court.
